- The rate should be F.O.R. GAIL DAV Public School and <u>should include all taxes</u>, freight charges, any other taxes, rates <u>or imposition which are leviable e.g.</u>, packing charges in respect of the supplies. The school/institution will not be liable to pay any tax, freight, etc., which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
